## **Policy**

Given the seemingly never-ending amount of challenges facing Britain's economy over the last few years, there has never been a time when the Chamber's voice and powers were needed more. The unique structure of West & North Yorkshire Chamber of Commerce has meant we have established policy groups that can zero in on the areas of greatest economic need to deliver for the region.

Across our various groups, we boast a collective brain of the region's finest business leaders and their membership boasts thousands of years of experience across the Chamber.

Since the last Annual Report was published we have seen three Prime Ministers and the death of Her Late Majesty the Queen. Given the political upheaval we have seen, it has been somewhat inevitable that the momentum behind Levelling Up and the Northern Powerhouse has dwindled. With a general election set for next year, we as a Chamber will be pushing hard to see it restored to the political forefront.

#### **British Chambers**

The aforesaid upheaval in Britain's politics and economy has meant Chamber activity nationally has been in overdrive. The new BCC Business Council was officially launched in the Spring to significant fanfare. Thanks to the high level of access the Chamber nationally has, we have been able to press the case on inflation, tax, interest rate woes and the Labour market. The Northern Regional Assembly of all 16 Chambers in the North of England is going from strength to strength.







### **Economy**

As the producers of Britian's biggest economic report, The Quarterly Economic Survey, the Chamber has its finger firmly on the pulse of what is happening in terms of British business sentiment and outlook. After the traumas of the second half of 2022, there has been a marked improvement in optimism regarding revenues and profitability since the start of the year.

Sales, both domestically and internationally, remain a veritable mixed bag across both manufacturing and service sector firms. Investment appetite is minimal but, while there is little sign of firms looking to recruit staff in large volumes, there is even less evidence of firms in Yorkshire looking to cull personnel.

### Transport & Infrastructure

Despite chopping and changing in the world of politics, there have been some positives to take on transport infrastructure after a torrid few years of disappointment. While the much-decried Integrated Rail Plan remains Government policy, there are encouraging signs that the Government may be beginning to shift its position on Yorkshire. It now appears ministers recognise that Bradford needs to be granted a through railways station, with the Department for Transport set to revisit the plan. By the time this report is published, West Yorkshire Combined Authority will be preparing to publish its plans and timelines for mass transit in the region.

Work on City Square in Leeds has posed a great deal of disruption but should be entering the final stage of construction as this report is published. Further work to improve Leeds Railway Station is now underway following years of lobbying by the Chamber. The Chamber is also continuing to lobby for improvements to York Outer Ring Road and the A64.

#### **Environment**

Despite the continued uncertainty, businesses in the region continue to show increasing demand for reviewing and overhauling their environmental credentials. West & North Yorkshire Chamber has staged numerous events across the wider geography to share best practice and bring in industry experts. The Green Business Hub continues to provide advice and signposting to firm in need of assistance in their journey to net zero. Details can be found at www.wnychamber.co.uk/green-business-hub.

# Hospitality

The Chamber made history in January when it launched the first ever Hospitality Forum since Chambers of Commerce were formed in Britain. Set up in North Yorkshire to champion the sectors crucial role in that economy, the forum has enjoyed a great deal of support and media attention, culminating in a visit by Chamber staffers and York & North Yorkshire president elect Sarah Czarnecki to Westminster in the Spring to meet with Government minister John Whittingdale and a raft of the region's MPs.

## **Policy Events**

The Chamber has hosted a raft of events across the patch this year, most notably when it welcomed the Bank of England Governor Andrew Bailey to Leeds. Our Property Forums have engaged high profile speakers from the world's of local government, environmental governance and international development.

Bradford Manufacturing Weeks and Leeds Manufacturing Festival continue to be highly successful events and the Chamber has hosted a number of high profile opportunities for executive and patron members, including visits to the House of Lords, the Great Yorkshire Show and York Racecourse.









# Marketing

Over the last 12 months, we've seen a phenomenal level of organic growth across our platforms, breaking the 12K barrier on the main West and North Yorkshire Chamber X (formerly Twitter) page, and growing our LinkedIn following by a further 23%. As we've grown, we've adopted more automation, making a more dynamic connection between articles posted on our website and on our social media platforms.

Since April last year, we've shared nearly 300 news articles and posted over 100 member offers on the member news section on our website. The visitor numbers have doubled in the last period and through the onboarding of key Patron and Executive members, our distribution has grown stronger and more prestigious.

### Membership

We have seen a fantastic increase of 37% in the number of new members recruited. Access to funding has assisted so many businesses, offering them additional support towards their membership. We are delighted to report a decrease of 23% in the number of member resignations. An increase in the usage of the legal advice line has resulted in an estimated £45,615 of savings.

- Almost 92% increase in new member subscription income
- 20% decrease in lost subscription income due to resignations

### **Property**

This year we have invested in further carbon reduction measures at the Business Park. An external LED lighting scheme has reduced energy use and improved security. The installation of new efficient boilers and building heating controls to the 3-storey office block has reduced gas consumption and mitigated increases in utility recharge costs for tenants.

Our hybrid units at the Business Park have maintained 100% occupancy for the whole year. At Commerce Court and City Hub, a 95% occupancy has been maintained.

#### **Chamber International**

The number of workshops delivered on international trade subjects this year is 67. This resulted in the training of 435 delegates. Over twenty consultancy projects were undertaken and 17 people enrolled on the Excellence Academy and were successful in achieving the Academy's International Trade Qualification accredited by the British Chambers of Commerce. 13,907 export documents declared a total value of £759,810,014

December 2022 saw Chamber International being invited by British Chambers of Commerce along with three other UK Chambers to trial 'Genesis', a revolutionary new digital platform that verifies the origin of exported goods. The platform was developed by the International Chamber of Commerce and is being trialled simultaneously by Chambers in Canada, The Netherlands and France.

# Diversity

Our Black, Asian and Minority Ethnic (BAME) committee has grown in numbers as we look to become the most progressive and diverse Chamber of Commerce in the country over the next few years. It's important that as an organisation our workforce and members reflect the diversity of sectors and communities we represent. There is work still to do here but with the right people alongside us we can ensure business support is available to all.







#### **Events**

We finally transitioned back to a calendar of face-to-face events. We've kept a selection on online, which includes Bitesize Boardroom and topical events such as the Queen's Award for Enterprize (now renamed the Kings Award for Enterprise).

This year, we launched Netwalking. This type of networking has become our most popular event so far. Come rain or shine, members and non-members are out in force, making new connections and sharing experiences. We made a change to the look and feel of our large Annual Dinners, becoming more inclusive and modernising the dress code. We had Punjabi drummers, local to Bradford, bringing our members a taste of culture in a city famous for its diversity at the Bradford Annual Dinner. The Leeds Annual Dinner delivered a panel of Yorkshire voices and tapas-style food bowls. The York & North Yorkshire Dinner moved to a new location at York Racecourse, and had a discussuion panel, and performances by local music students and rounded off with music by Huge party band.

Partnering with the British Chambers of Commerce, we've brought our members' 'Round table' discussions, highlighting key issues we're working on as a chamber. One such visit saw us discussing Net Zero and how to achieve it in West Yorkshire. We also began running property and hospitality forums to support our smaller businesses with large-scale national policy changes, answering any questions they may have.

#### **Business Services**

The West and North Yorkshire Chamber were successful in their submission for delivery of the Local Skills Improvement Plan (LSIP) in West and North Yorkshire.
