

POLICY UPDATE: JANUARY 2024

Regional / National

Transport

Members of the Policy & Representation team – plus several members of our Transport Group – attended one of the two recent all-day conferences organised for stakeholders of the Trans-Pennine Express rail group. (The conference was repeated in the two cities of York and Manchester.)

The well-organised event (with around one-third of attendees being TPE personnel) is part of an ongoing PR exercise for the TOC (train operating company) to rebuild relations with customers and others. (In a separate discussion, the Chamber is looking to put on an event to discuss trans-Pennine rail services.)

Flood Resilience

The team are working with organisations to help create a community interest company (CIC) to help tackle flooding in parts of West Yorkshire.

Although it is initially focused on protecting Leeds, it is recognised that the River Aire catchment area goes all the way to Malham so also passes through the Bradford District area. The team have been liaising with the Environment Agency, Rivers Trust and Leeds Council, who have all recently met with and presented to the Chamber's Sustainability Group. We have also promoted two recent webinars, which we know some members joined.

Private Equity Scrutiny

Team members attended a lunch with some of the sub-region's key players in the private equity and mergers and acquisitions sector. The Business Desk Rainmakers' seminar was attended by around 60 and helped inform the team in this important policy area. Property and Economic Forum

The Chamber hosted a roundtable in collaboration with City of York Council, focused on developing relationships with developers and planners in the city for the benefit of those living and working in York. The paper following this event is currently being finalised and recommendations will form part of further co-working with the council.

The group submitted consultation response to the Community Infrastructure Levy consultation.

Tourism

A member of the team attended four of the five sessions on the North Yorkshire Destination Management Plan. This was to finalise the action plan for the DMP and address immediate concerns. The Chamber were explicit in the need for more involvement with businesses, particularly in hospitality and tourism, and will be involved in the action plan going forward.

Environment

The Policy and Representation Executive and chair of the Property and Economic Forum attended the York Climate Commission relaunch, focusing on sustainability within many facets of life, from waste to transport. The Chamber will be represented at the steering group going forward, and will lead on the Future Economy group focusing on green skills and jobs.

Civic Duties

Team members attended the Executive Lunch. As well as good networking opportunities, we also hosted a table and managed to catch up with some members of our York & North Yorkshire policy groups. The speaker was Andrew Morrison of York Civic Trust.

A scheme that will provide the city centre with up to one thousand homes.
